B-1/B-2 Visas for 10 Years:

C-2 Visa Nonimmigrant:

Freedom to travel in Schengen Area, C-2 Visa nonimmigrant, Validity Up to 5-Years, Unable to Live or Work.

Stay in Schengen area upto 90 days, relocate the USA or offer freedom to your life and for your family "Comfort Zone".

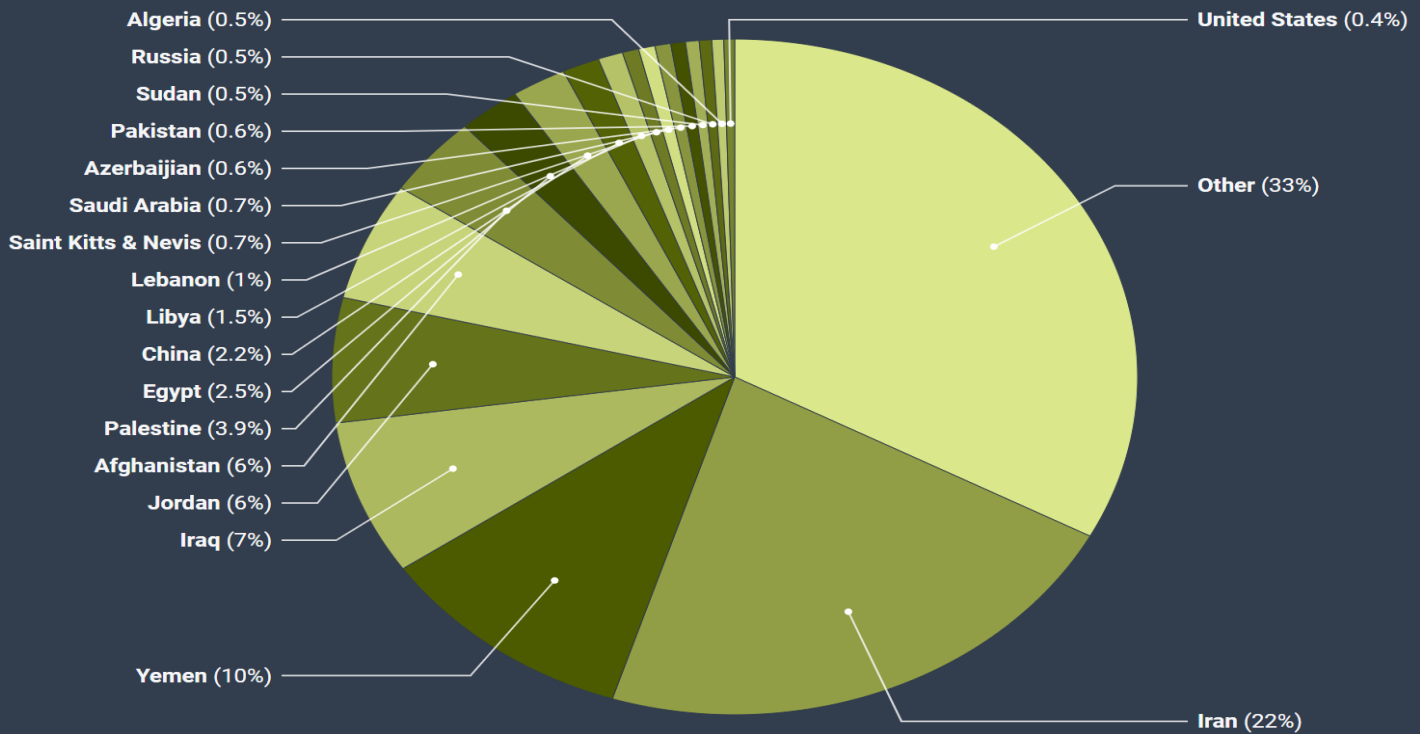
